Review April Minutes

Status of June Show

We need to wait until the “Stay at Home/Stay Safe Ohio” order and 10 person gathering are lifted before we can make a decision about the June show. We all want to have the show but we cannot do so without the restrictions being lifted. We will continue to monitor the situation and make updates and changes as needed. Donnie will confirm that other weekends are available in June if the June 6th date is not possible. If we are not able to have a show in June we will look at what alternative options are available.

Plan for Set up/Clean Up Day

We are not able to plan a day at this point. Once the 10 person gathering is lifted we will set up a day in preparation for our first show.

Treasurers Report

The balance after the awards banquet is \$16,085. Lori will prepare a breakdown of what was spent for the banquet and awards and how much we recouped from the auction. Taxes have been filed and insurance has been paid for the year. The fairgrounds lease has also been paid for the year. We will request a reimbursement for any shows that cannot be held or the balance will carry over to 2021.

Freestyle Reining

It was suggested that for the 2020 Freestyle Reining exhibition and future years we begin offering prizes for youth exhibitors as well as the overall winner. Close to 50% of the entries in 2019 were youth. We want to reward and acknowledge their participation.

Roping Clinic

It is our recommendation that we hold the roping clinic on the Friday evening of the first show we are able to have. So, this would be June or July depending on when our first show is. The goal of the clinic is to introduce the event to new exhibitors. Once the new date is confirmed we will post a new event.

Open Discussion

Ribbons

The ribbons will be \$1200 to order for the year. Angie will go ahead and order the ribbons as they can be carried forward into future years.

Banquet for 2021

It was suggested that we look at holding the banquet at the Southgate Hotel. Several members stay at the hotel for the banquet. This would make set up and clean up easier. We will check with the hotel for pricing and catering. We want the current caterers to continue to provide the food and drinks.
